

THE NEW ZEALAND SCREEN PRODUCTION GRANT INTERNATIONAL

The New Zealand Screen Production Grant is a modern, generous, Government-backed incentive that offers a 20 per cent grant for international productions. Many productions will qualify.

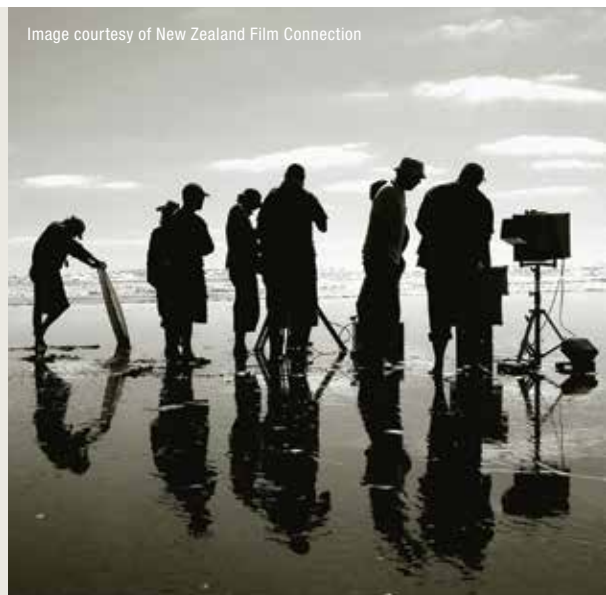

More Advantages

- ▶ Cash grant (not a tax credit)
- ▶ Fast – usually paid out within three months of application
- ▶ Generous definitions of qualifying spend (QNZPE) with few exclusions (i.e. most items count including goods, services, labor and some international travel)
- ▶ Uncapped for above-the-line cast (while working in New Zealand)
- ▶ Uncapped for crew if in New Zealand for 14+ days
- ▶ Reliable – it's Government backed
- ▶ The fund won't run out

MANY PRODUCTIONS WILL QUALIFY FOR A 20% GRANT

A smaller number of productions may be eligible for an additional five per cent grant. You will have to take the Significant Economic Benefits (SEB) Test. To qualify as bringing significant economic benefits to New Zealand a production must either:

- ▶ score a minimum of 20 out of a possible 30 points (with a minimum 1 point in Section A and 3 points in Section D in mandatory categories), or
- ▶ achieve 'Fast Track' status and meet the minimum (and mandatory) points requirements in Section D.

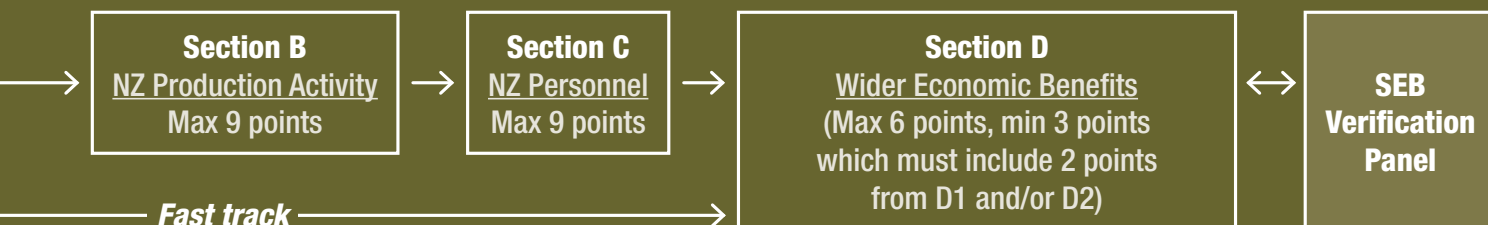

B DOES YOUR PRODUCTION INCLUDE SIGNIFICANT NEW ZEALAND PRODUCTION ACTIVITY?

Except for B1 (Shooting) which is calculated by reference to the number of days, the percentages in B2 to B6 are based on the QNZPE in relation to the total budget. This will include: where a person works on a film, where goods are supplied from and/or where the services are performed.

Where expenditure on a film-making activity is split between activity inside and outside New Zealand then expenditure must be claimed in proportion to the location of that activity. Information regarding the ownership of any equipment and technical facilities used by an applicant to claim points under this section may be requested.

C DOES YOUR PRODUCTION INCLUDE NEW ZEALAND PERSONNEL IN KEY ROLES?

For the purposes of this test, a qualifying person means a citizen or a permanent resident of New Zealand. To qualify, a person must be a qualifying person at the time the production is made. If a person holds dual nationality he/she may choose either nationality.

D DOES YOUR PRODUCTION PROVIDE WIDER ECONOMIC BENEFITS TO NEW ZEALAND?

Section D relates to marketing and promotion of New Zealand, placement of New Zealand in the screen production, investment in infrastructure, innovation, technology or knowledge transfer, skills or talent development.

Mandatory Requirements (Section D1 and D2)

Different productions have different showcasing value for New Zealand and this is recognised in the points.

Section D1 – Up to 3 points are available for marketing, promoting and showcasing New Zealand or the New Zealand screen industry resulting in positive brand recognition (over and above what would normally be required).

More points are available when a strategic partnership can be developed with a New Zealand Government agency or related entity. Imaginative proposals are encouraged including cross-sector marketing or initiatives that may open up new markets to New Zealand or give better access to capital, tourism, screen or other markets which would involve a high level of engagement.

It is expected that to achieve 2 or 3 points in D1 applicants will be able to demonstrate the geographic and demographic markets their production will reach, and that these align with New Zealand's interests. They will also need to demonstrate capacity to work with New Zealand to realise effective marketing partnerships.

Section D2 – New Zealand recognises that some productions offer the possibility to incorporate New Zealand on screen. For example, a screen production may utilise an identifiable New Zealand setting or New Zealand performer to play a New Zealand character in a significant role. Up to 2 points are available.

The scale of benefit to New Zealand should meet or exceed the value of the 5% uplift.

SIGNIFICANT ECONOMIC BENEFITS (SEB) VERIFICATION PANEL

The SEB Verification Panel will determine whether a production and applicant pass the SEB Test and are therefore eligible for the five per cent uplift.
